In accordance with our Bylaws, a member in good standing for the purpose of voting, nominating and candidacy shall be those members shown on the National records as paid as of October 31, 2009.

Below are the qualifications for the applicable Board of Director and Regional Officer positions:

### **National President/National Executive Vice President**

Only a member of the Board of Directors or a past member of the Board of Directors who has served on the Board within two years immediately preceding the current fiscal year may be nominated of President or Executive Vice President. These members are required to have:

- a minimum of five (5) years professional membership and
- two (2) years of service as a member of the Board of Directors.

### **National Treasurer**

These members are required to have:

- five (5) years professional membership and
- two (2) years as a member of the national finance committee or
- two (2) years as a member of the Board of Directors or
- two (2) years as a treasurer at the regional level.

### **National Secretary**

These members are required to have:

- five (5) years professional membership and
- two (2) years as a member of the Board of Directors or
- two (2) years as an officer at the regional level.

### **Regional President**

These members are required to have:

- five (5) years professional membership and
- two (2) years as a chapter president or
- two (2) years as a regional officer or
- two (2) years as a member of the Board of Directors or
- three (3) years as an officer at the chapter level

### National Director

These members are required to have:

- five (5) years professional membership and
- three (3) years as an officer at the chapter level or
- three (3) years as a member of a national committee or
- three (3) years as a chairperson of a local or regional committee or a member of regional leadership team

### Regional Chapter Representative

These members are required to have:

- five (5) years professional membership and
- two (2) years as member of a national committee and
- two (2) years as an officer at the chapter level or
- two (2) years as a chairperson of a local or regional committee.

### Regional Vice President

These members are required to have:

- four (4) years professional membership and
- one (1) year as chapter president or
- one (1) year as regional officer or
- one (1) year as a member of the national committee or
- three (3) years as a chairperson of a local or regional committee.

### Regional Treasurer/Regional Secretary

These members are required to have:

- three (3) years professional membership and
- a minimum of three (3) years as a chairperson of a local or regional committee.
